we would hereby like to inform you about the merger of the following companies:

BOHEMIA TECHNICAL TEXTILES, s.r.o., (id. no.: 251 03 253)  
with its registered office in Litomyšl, 570 01, Smetanovo namesti 58  
entered in the Commercial Register kept by the Regional Court in Hradec Kralove, Section C, Insert 12999  
(as the company being acquired)

and

BOHEMIA TEX-HOUSE, s.r.o., (id. no.: 259 18 249)  
with its registered office in Litomyšl, PSČ 570 01, Smetanovo namesti 58  
entered in the Commercial Register kept by the Regional Court in Hradec Kralove, Section C, Insert 14466  
(as the successor company)

Based on the final resolution of the Regional Court in Hradec Kralove – branch Pardubice, ref. no. F 25236/2010 dated 14th December 2010, a merger by above mentioned companies will be effected as of 4th January 2011 in accordance with the relevant legal regulations. On the said date, BOHEMIA TECHNICAL TEXTILES, s.r.o. will be wound up without liquidation and deleted from the Commercial Register. The successor company BOHEMIA TEX-HOUSE, s.r.o. will become the legal successor to BOHEMIA TECHNICAL TEXTILES, s.r.o., and all of the assets (including all liabilities and claims), rights and obligations, including the obligations arising from labour relations of the company being acquired, shall pass to the successor company. In this regard, it is therefore not necessary to establish new or alter the existing contractual relationships with business partners.

In connection with the above-mentioned merger, we would also like to present the following brief instructions of administrative nature:

- Starting from 4th January 2011, please direct all communication with us to BOHEMIA TEX-HOUSE, s.r.o., with its registered office in Litomyšl, 570 01, Smetanovo namesti 58, id. no. 259 18 249, only.
- Invoices for deliveries of goods and services ordered by BOHEMIA TECHNICAL TEXTILES, s.r.o. - if delivery was effected by 3rd January 2011 (inclusive) - should be issued to the said company, even if such invoices are issued after 3rd January 2011.
- Invoices for deliveries of goods and services ordered by BOHEMIA TECHNICAL TEXTILES, s.r.o. - if delivery was effected after 3rd January 2011 - should be issued to the successor company BOHEMIA TEX-HOUSE, s.r.o.
- This means that all orders placed by BOHEMIA TECHNICAL TEXTILES, s.r.o. on the basis of which deliveries of goods or services were not effected by 3rd January 2011 continue to be valid and will be executed for BOHEMIA TEX-HOUSE, s.r.o.
- Likewise, all orders placed by clients with BOHEMIA TECHNICAL TEXTILES, s.r.o. on the basis of which deliveries of goods or services were not effected by 3rd January 2011 continue to be valid and will be executed by BOHEMIA TEX-HOUSE, s.r.o.
